The Argentina localization for Microsoft Dynamics 365 Business Central was developed to align the system with the country's tax and legal requirements. The solution covers core accounting processes, electronic invoicing, perceptions, withholdings, and report generation — providing companies with the necessary tools to ensure compliance with AFIP (Administración Federal de Ingresos Públicos), ARBA (Buenos Aires Revenue Agency), AGIP (CABA Tax Administration), and other Argentine regulatory bodies.

This document outlines in detail the features available in the Argentina Localization for Business Central. Any needs not specified in this material are considered outside the current scope of the solution.

#### **Architecture**

The Argentina localization for Microsoft Dynamics 365 Business Central was developed to adapt the system to the country's fiscal, accounting, and tax requirements. The solution is designed for companies that operate with electronic invoicing,

province-specific taxes and withholdings, integration with local systems, and compliance with obligations to AFIP, ARBA, AGIP, and other regulatory agencies.

### **Key benefits**

- **Guaranteed compliance with Argentine** regulations: Aligned with current legislation, including VAT, IIBB, Income Tax (Ganancias), AFIP regulations, and provincial and municipal requirements.
- Fiscal and accounting flexibility: Manages documents and reports across multiple jurisdictions and tax scenarios (such as simplified tax regimes and large taxpayers).
- Integration with local entities: Compatible with ARBA, AGIP, SiAP, e-ARCIBA, and others.
- Automation of obligations: Automates the calculation and issuance of perceptions, withholdings, electronic documents, and customs declarations.

Other Features	RG 3685 – Citi Purchases/Sales	Generation of mandatory purchase and sales reports.
Other Features	E-ARCIBA	Connection to ARCIBA's electronic banking system.
Other Features	NC and ND with reference document	Issuance of corrective invoices linked to the original invoice.
Other Features	A-type invoicing for simplified taxpayers ou small taxpayers	Generation of documents suitable for the simplified regime.
Other Features	Inflation Adjustment	Automatic monetary corrections in accordance with legal requirements.
