Architecture

The Mexico Localization for Microsoft Dynamics 365 Business Central is part of AlfaPeople's Latin America-wide localization strategy.

It can be implemented independently in a dedicated tenant for Mexico or jointly with other country localizations within the same tenant, enabling centralized management of multi-country operations.

Built on the international (W1) version of Business Central, it offers a flexible, standardized architecture aligned with global best practices.
