The Peru Localization for Dynamics 365 Business Central is part of a comprehensive localization framework for Latin America. It can be deployed independently in a dedicated tenant for Peru or together with other regional localizations within the same tenant, enabling centralized management of multi-country operations in a single instance of Business Central.

Built on the international (W1) version of Business Central, the solution provides a flexible, standardized architecture aligned with Microsoft's global best practices. Unlike other localizations, it supports modular implementation — either as a standalone solution or integrated with other
