Configuration Location	Sales invoices	Generates sales invoices with VAT and other applicable taxes.

Configuration Location	Fee Books	Report of purchase and sales transactions with VAT, summarized on a semi-annual basis. With holding.
Configuration Location	VAT report for purchases/sales, semi-annual.	Report of purchase and sales transactions with VAT, summarized on a semi-annual basis.
Configuration Location	Currency adjustment	<p>Applies to fixed assets and inventories.</p> <ul style="list-style-type: none"> • Currency correction calculation • Factor parameterization
